

# **Loan Car Terms and Conditions**

#### Cost

A hire fee of \$10 per day is payable before you take the loan car, unless otherwise discussed and arranged.

### **Petrol**

You must pay for petrol while the loan car is in your possession during the time of repairs. Please return the loan car with petrol at the same level as when picked up.

## **Duty of Care**

Customers should;

- exercise all reasonable care while loan car is in your possession
- not drive the loan car whilst under the influence of alcohol and/or drugs
- not sub-let or allow any other person to drive the loan car
- abide by all Traffic Regulations

### **Fines & Tolls**

Granite Belt Body Works will not be responsible for any fines or breaches of traffic regulations. All Toll road travel, parking costs or fines, speeding fines or other infringements during the loan period are the responsibility of the detailed driver and any infringements received will be forwarded to you.

## **Damage to Loan Car or Third Party Damage**

If you damage the loan car in any way please let us know as soon as possible. Depending on the extent of the damage we will decide if we will cover the costs or need to make an insurance claim. If an insurance claim is made the Comprehensive Insurance Cover on this vehicle involves the payment of excess by Granite Belt Body Works. You may be required to pay the whole or part of the excess.

In the event of the loan car being involved in a collision with another vehicle, person or object, whether damage is sustained by the vehicle or otherwise you will need to provide us with full particulars of the circumstances surrounding the collision. Particulars shall include the name and address of the person or person's involved, registered number of other vehicle, names and addresses of witnesses, and sketch plan with measurements and marking of all skid marks and points of impact.

Accidents can happen, if you hit another party whilst using the loan car you are covered under our insurance and we advise that you send the third party to us directly.

# Liability

You will not make any claim against Granite Belt Body Works for any personal injury, damage, inconvenience, delay or any other matter arising from or incidental to any breakdown, mechanical (or otherwise) or any accident.

You agree to indemnify Granite Belt Body Works against all claims and demands of injury, damage or loss arising out of the use by me or my agents and whether in respect of death or injury, to person/s or damage to property and to further indemnify Granite Belt Body Works against all costs resulting from any breach of the Road Traffic Act 1958 the Motor Regulations Act and or Municipal Authorities By Laws.

## **Returning the Loan Car**

You will return and deliver the loan vehicle at your own expense, including breakdown service (if any), complete with all its tools, accessories, and equipment to Granite Belt Body Works, in the same condition as when you received it. The car will be returned with the same amount of petrol as when first taken.
